Throughout 2023, The Price Center celebrated The Year of the Employee. We celebrated the achievements and milestones of our direct care staff, our administrative team, and the support staff who help make The Price Center an amazing place to work.

Some staff include our very own Price Center participants, hired and trained by our Employment Services team. Their continuous passion and enthusiasm for what they do help shape the programs they work in while building a strong community of support that encourages their growth, participation, and success.



Meet Marisa, a participant in our Community Based Day (CBDS) program. While Marisa has attended CBDS since 2018, she is celebrating another milestone.

For three years, Marisa has worked for The Price Center cleaning and organizing the Intensive Day Habilitation (IDH) program room and kitchen. She performs general upkeep, such as doing the dishes, sweeping the floors, and wiping the cabinets. She also assists the direct care staff getting individuals ready for lunch; cleaning adaptive equipment, pulling out lunches, and setting up tables and chairs.

"I really like cleaning," Marisa said. "I have great coworkers, and just really like all of it. [Cleaning] is in my blood," she joked. "I'm a natural talent."

When she was looking for a job, Marisa said she knew she wanted to do something with cleaning. She said that she loves to clean at home and wanted to utilize the skills she learned at home and in Price Center programming in a working environment.

Besides tidying and prepping the program area and kitchen, Marisa waters the plants, refills beverages, and does the occasional coffee run for the direct care staff.

Marisa has really become part of the team," said David Byrnes, the Program Director for IDH. "She works well with staff. [They] absolutely love her."

Although Marisa loves the work she does in IDH, the



relationships that she's formed with the IDH staff and participants is what means the most to her.

Outside of her work in IDH, Marisa is also a Price Center Ambassador. They attend and host Price Center events, including the Open House and Fall Festival. Their platform lets them speak about their experiences at the Price Center and to talk about being part of the Price Center community.

"[the Ambassador program] is a great idea," she said. "It's super leadership-like!" A self-described free spirit, Marisa loves having fun outside of work just as much as she does while doing it. She loves coloring, cooking, and practicing her karate skills in her free time. 🎨

The new group offers a place for Price Center siblings to call their own. It is a safe space for brothers and sisters of attendees to share their emotions, thoughts, and challenges with others living in a similar reality. Sibshop offers a place with the resources, guidance, and assistance that comes with the responsibility, privilege, and birthright of being a sibling to someone with the unique gifts of their different abilities.

The group promises to provide the tools necessary to understand, prepare, and execute the incredible and sometimes difficult role they have acquired.

Created by the Sibling Support Project, Sibshops are agency-sponsored programs organized and run by siblings, for siblings. Sibshops provide a sibling-only space to meet and connect with fellow siblings, as well as educational resources, seminars, workshops, and so much more. By sponsoring a Sibshop, Price Center siblings will have the support and resources to grow and continue being the most amazing siblings to their loved ones.

One staff member, Employment Program Manager Crystal Palermo's passion and efforts were rewarded through the presentation of a Dougie Award, which was accompanied by the commitment of a \$500 donation, made in her name, to the charity of her choice, courtesy of the Doug Flutie Jr. Foundation for Autism. The foundation aims to help people and families affected by autism to live life to the fullest.

Emphasizing her passion for, and commitment to, The Price Center, Crystal said, *"I am donating the money to The Price Center. It's a great organization, and contributing in every way possible is truly fulfilling."*


The award resulted from the Flutie Foundation's call for nominations that highlight a "STAR in your life who shines bright in their own way and makes a positive impact on the autism community." Price Center employees and participants agreed that Crystal was that star! The Price Center's nomination read:

*"The Price Center is nominating Crystal Palermo, our Employment Program Manager, as our STAR who 'shines bright and makes a positive impact on the autism community.' She has worked at the Price Center for five years and, during that time, has provided 1:1 Job Coaching supports to a man with autism. One of our participants recently explained that [Crystal] provides excellent support. 'She is very helpful -- she helped me with my resume, interview, references and at my job, helps me focus on tasks.'*

Crystal's work ethic and the support she provides to our participants are well recognized and appreciated. The Dougie award highlights Crystal Palermo is our STAR!"

Crystal opened up about her personal connection to the work she has done - for over 20 years.

*"My uncle is on the spectrum," she shared. "When I was really young, I asked him if he could read to me. He said he did not know how. So I read to him. Ever since that day, I've been trying to support and empower my uncle and individuals, like him, in the autism community."*

With The Price Center supporting more than 20 individuals in paid employment, including 8 who've been with their employer and supported by Employment Services for more than 10 years and 8 who have been placed in the last 3 years, Crystal's efforts have borne fruit for the Center's participants.

## The Price Center Gives Back, too

The Price Center has always believed in creating a strong community inside the Center and out. To this end, we strive to help clients foster long-lasting relationships, set and meet development goals, and ultimately to realize each individual's full potential.

Throughout 2023 and 2024, our individuals created many new opportunities for themselves. From volunteering at different organizations to helping keep our neighborhoods clean, individuals in our Specialized Supports and Community-Based Day (CBDS) programs focused their efforts on giving back to the community.

Among our participants' favorite ways to give back and get out into the community is cleaning up the Franklin Park Zoo. Every week during late spring and summer, many of our individuals go to the zoo to water plants, tend to the gardens, and clean up around the park.

"We get to create a social opportunity by going," said Peter, a participant of CBDS. "It's something fun to do (and) we get to learn new skills."

Even though our participants are volunteering, they get a great payment in exchange: getting to see the animals every week.

"I like seeing the giraffes and the monkeys," said Ian, a CBDS participant. "I like weeding the gardens and laying the mulch, but the animals are fun."



While the zoo is one of the more popular outings our individuals go on, The Price Center has, and continues to look for -- new ways to get clients outside and active. Another volunteer opportunity was right in our own backyards.

"My favorite [volunteering opportunity] is landscaping," said Long, a Specialized Supports attendee. "I like mowing the lawn."

For the past year, small groups of individuals have been going to our residential homes to landscape and clean. Those efforts assist our residential staff in keeping our homes happy, healthy, and clean and our participants learn valuable skills while having fun outdoors.

"I like raking the leaves and picking up the garbage," said Sean, a participant of Specialized Supports. "I also like to give the bushes a haircut!"

While staff join our individuals on their landscaping trips, they are frequently joined by two special guests. Andy Gluck and Gary Hofstetter, two members of our Board of Directors, have been assisting with some of the landscaping work. Their work helps our individuals develop skills while keeping our residential homes looking beautiful.

"Andy and Gary are great helpers," Sean shared. "They work really hard! They like to joke that they're hardly working."

Throughout the years, Price Center staff have noticed how much our program participants love to help others. From cleaning the zoo to collecting donations for non-profits, The Price Center has developed partnerships that give our individuals the opportunity to be strong and productive pillars in the community.

One partnership that has benefited not just our individuals but also our community is with Springwell, a non-profit that provides services to seniors and their caregivers. Each week, individuals in our community programs go out and grocery shop for Springwell residents.

"I like when we go to Trader Joes," Long said. "I like [being able] to help people."

Different groups go out to different stores each week. Some weeks, a group will go to Trader Joes to shop. Other times, a group may go to Market Basket, BJ's, or Stop n Shop. Our individuals work hard to get everyone what they need from their grocery lists.

"Price Center is doing a nice thing [by going to Springwell]," Sean said. "I like bringing the groceries inside and helping people. It's important to remember that we need to help people in the community."

As we focus on the growth of our organization and ways we can make our programs stronger, we look at how impactful these opportunities are for our individuals. We look to our community who have welcomed us with open arms, and to our individuals who are constantly exploring new volunteer initiatives. With such a strong foundation, we look forward to continuing on the path of excellence and progress. 🧑🏻‍🌾



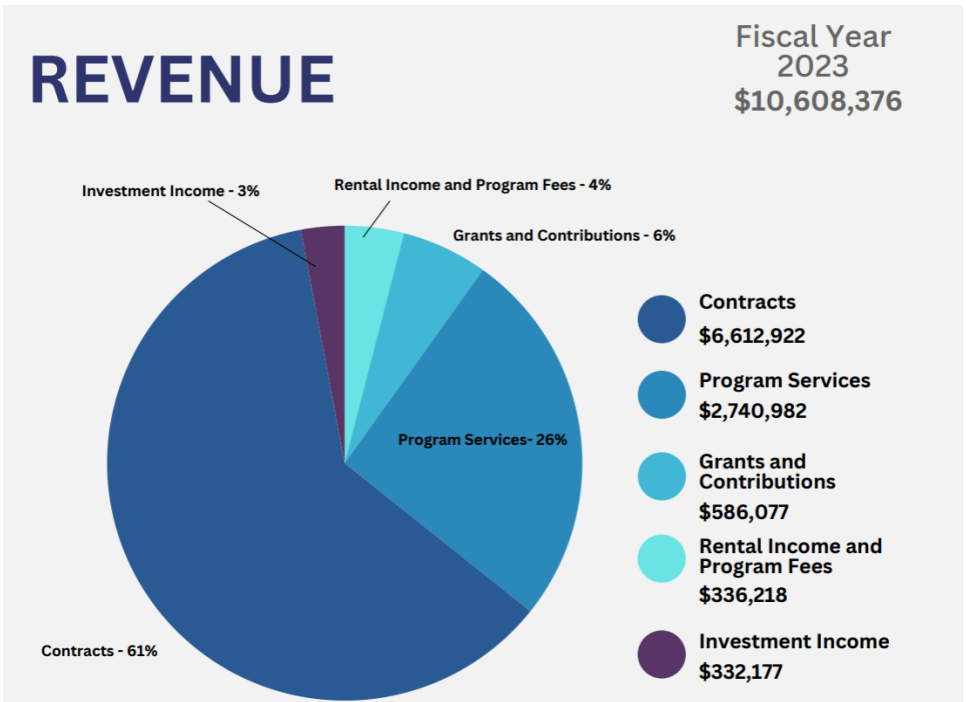
# Financials

Throughout fiscal years 2023 and 2024, The Price Center made significant investments in the future of the organization while continuing to prioritize client wellbeing and progress.

We named fiscal year 2023 as the “Year of the Employee” to demonstrate The Price Center’s commitment to its staff. During that fiscal year, we began instituting a new pay structure to better give all staff a way to grow professionally in the organization. Moreover, we invested to offer greater access to multiple bonus opportunities with an emphasis on training and certifications. In addition to investing in our staff, we added many more individuals in our residential program. These additional placements filled vacancies brought on by the COVID-19 pandemic and resulted in a significant increase in our DDS revenue, enhancing our bottom line.

In fiscal 2024, The Price Center made a significant investment in our direct-care workers by increasing their starting wage. The purpose was to use this investment to attract and retain the best staff through improved recruitment and professional development. We continued to make quality programming a priority and grow programming beyond the pre-pandemic levels.

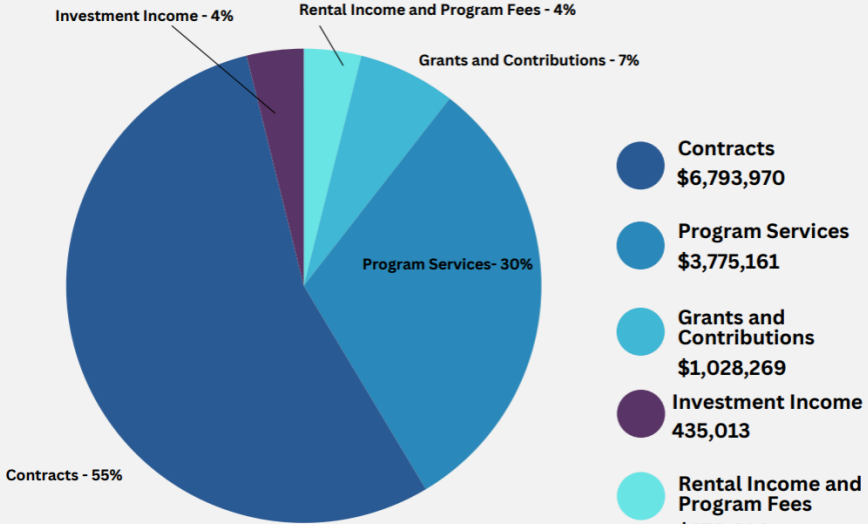
These investments reflect our goal of offering quality, life-changing programs to our community and expanding our services to more individuals with intellectual and developmental disabilities and Autism.





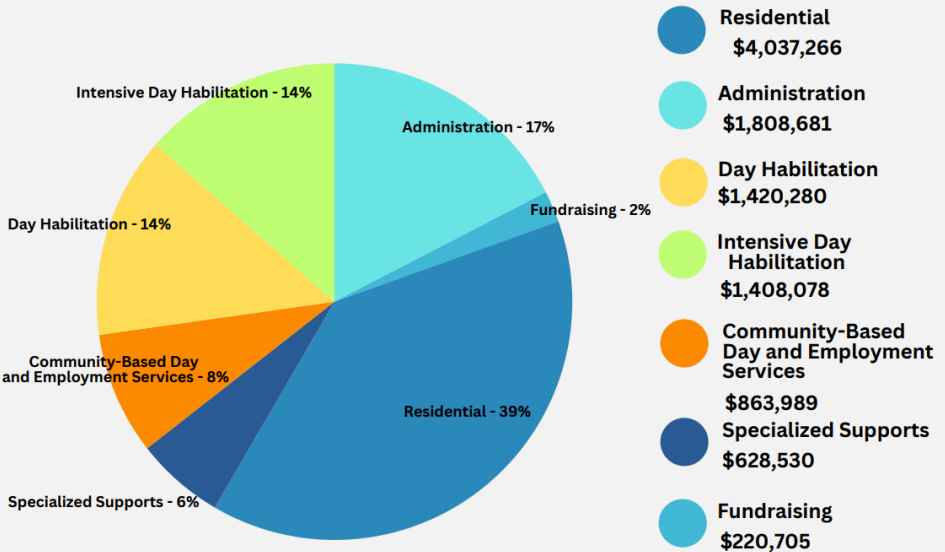
# REVENUE

\$12,402,657



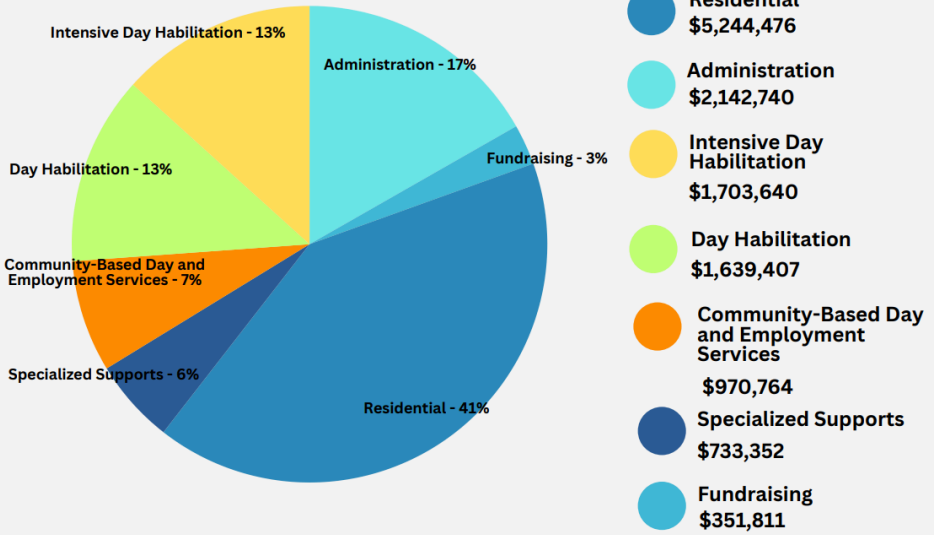
# EXPENSES
